

# PURCHASE TERMS AND CONDITIONS

## GENERAL SALES AND PARTICIPATION TERMS FOR THE 37TH IASP WORLD CONFERENCE

**Ownership and service provider:** EVENTISIMO, S.L., as responsible of this website and service provider of the information society, regarding the registration process and ticket sales for the 37TH IASP WORLD CONFERENCE, commercialized on behalf of the PCT CARTUJA, and in accordance to the current applicable law of Services related to the Society and Electronic Commerce Services (*Ley 34/2002, de 11 de julio, de Servicios de la Sociedad de la Información y de Comercio Electrónico*), makes the following general information available to users:

**Scope of Application:** The Spanish Law on Information Society Services and Electronic Commerce (LSSI) applies to the following services offered via Internet when they constitute an economic or profitable activity on the part of the service provider.

- Electronic commerce.
- Online hiring.
- Information and advertising.
- Mediation services.

It is considered that there is economic activity involved when the responsible of the website receives direct income (for the e-commerce activities provided) or indirect income (either by advertising or sponsorship derived from the activity accomplished by electronic means). The Law is directly applicable to all activities that are carried out electronically and that are commercial in nature or may have an economic purpose.

EVENTISIMO, S.L. is responsible of the event website on behalf of PCT CARTUJA, and makes available to users this document aimed to the compliance with the obligations set forth in Spanish Law 34/2002, of July 11th, on the Services of the Information Society and Electronic Commerce (LSSICE) and in the Royal Legislative Decree 1/2007, of November 16th, which approves the consolidated text of the General

Law for the Defense of Consumers and Users and other complementary laws, as well as informing all its clients Regarding the conditions of use of the website.

***Management of participation and ticket sales for the 37TH IASP WORLD CONFERENCE:*** The confirmation of the registration request at the 37TH IASP WORLD CONFERENCE involves the acquisition of the role of attendees, applicable to all people who are of legal age and with full legal capacity to purchase the services. All attendees will have access, prior to the formalization of the registration, to the following information available on the website of the 37TH IASP WORLD CONFERENCE:

- Characteristics of the event.
- Prices and taxes.
- Terms and Conditions of the promotion or discount, if applicable.

Once the type of registration has been selected, attendees must properly fill in the requested information and then they will be asked to validate their purchase, accepting this LEGAL NOTICE AND GENERAL TERMS & CONDITIONS. After validating the chosen option, a confirmation screen will be displayed and they will receive, by email, after the approval of the payment, an acknowledgment of receipt in which all the terms of the contracted option will be recorded, then resulting in a valid purchase.

Once the user is registered, if requested, an invoice will be sent to the email provided by the user, or by regular mail to the contact address provided if no email was indicated.

All documentation will be generated in the English language.

Attendees/users also declare to know that the amount of the registration indicates the total price, including taxes. Prices are indicated in euros. Prices and conditions expressed are valid only as long as they are available on the website, and always limited to the available stocks. The owner of the website reserves the right to change prices at any time, in all cases respecting the current tariffs and rates of pre-existing applications. Payment will be made immediately upon attendee validation. Payment will be made using any of the following forms:

- **Credit card:** Accepted credit cards are all those belonging the *Visa* and *Mastercard* circuit. During the purchase procedure, neither the owner nor the responsible of the website will know any information related to the credit card, which is digitized

directly on the payment gateway of the entity that issues the card (with security systems that prevent interception, modification, or information forgery). No computer file of the owner or responsible of the website contains or retains such data. In any case neither the owner nor the managers of the website may, therefore, be held liable for any fraudulent and improper use of credit cards by third parties at the time of payment.

Attendees will be responsible for communicating all the necessary data for the correct billing, which must be truthful, current and adjusted to reality, especially regarding payment methods. Attendees will be responsible for the damages that may be caused to the owner and managers of the website or to third parties as a result of the use of outdated, false, inaccurate, or non-current data.

***Right of withdrawal:*** Attendees are informed, in accordance with the provisions of articles 102 and following of Spanish Royal Legislative Decree 1/2007, of November 16<sup>th</sup>, which approves the consolidated text of the General Law for the Defense of Consumers and Customers and other complementary laws, that they have the right to withdraw from the registration requested within 14 calendar days and without indicating any reason in this regard, except in the case that the event 37TH IASP WORLD CONFERENCE has started already. The attendee acknowledges and accepts to have been expressly informed of this right. As a consequence of this right, attendees will be entitled to reimbursement of the amounts originally paid prior to the celebration of the 37TH IASP WORLD CONFERENCE, using the same payment method as the one by which the payment was received.
